## Roadworthiness Inspection for Used Vehicles for Zanzibar:

The Zanzibar Bureau of Standards (ZBS) requires that a pre-shipment inspection for roadworthiness be carried out on all used vehicles imported into Zanzibar.

EAA Company Limited has been contracted to ZBS as an authorized inspection agency for the pre-shipment inspection for roadworthiness of used vehicles.

This inspection has been initiated by ZBS to minimize the risk of unsafe and substandard vehicles entering the Zanzibar market, thus ensuring health, safety and environmental protection for Zanzibar citizens. All used vehicles must meet the requirements of this important safety Pre-export inspection. Please ensure inspections are completed prior to export.

### Important factors of the Zanzibar roadworthiness inspection:

- The vehicle must pass the mandated roadworthiness inspection, and this includes the use of calibrated equipment for testing of braking systems, side-slip, radiation levels, emissions and lighting etc.
- There is no age restriction applied for vehicle imports into Zanzibar.
- Right-hand drive and Left-hand drive vehicles can be imported.
- Should the pre-shipment inspection not be completed prior to the vehicle export, ZBS will impose a penalty of 30% of the CIF value of the vehicle, in addition to the full cost of an inspection in Zanzibar.

## Application and inspection procedure:

- 1. Please send to us by Email or Fax an "EAA Application form for <ZANZIBAR ONLY>"
- 2. Ensure to attach the copy of Export Certificate of your vehicle. (Please note that the inspection cannot be conducted when there is no Export Certificate).
- 3. EAA will issue an invoice and email or fax it to you by return.
- 4. EAA will confirm the inspection place, the vehicle details, and the date of inspection booking via telephone or fax, once payment is confirmed.
- 5. After the inspection is completed and the vehicle is passed, EAA will send the inspection certificate to the Exporter.
