Used Vehicle Pre-export Inspection – Mauritius (commencing 1st January 2019)

The Government of Mauritius (*Ministry of Industry, Commerce and Consumer Protection – Commerce Division*)) has appointed EAA Company Limited (EAA) for the pre-export inspection of used vehicles exported from Japan, the United Kingdom, United Arab Emirates and Singapore and imported for use in Mauritius. This authority is Gazetted as per the Consumer Protection (Control of Imports) Regulations 2017.

This requires all used motor vehicles (except for the first vehicle imported by an individual importer) to be covered by an inspection certificate.

The pre-export inspection certifies the following for all used cars, vans, trucks and buses;

- Be righthand drive
- The vehicle is/has been inspected not earlier than 2 months prior to shipment.
- That the vehicle has not been reported as stolen.
- The vehicle must be in roadworthy and useable condition.
- The auction grade for the vehicle (3.5 or more).
- Has been subject to a vehicle condition report survey.
- Has not been subject to flood or water damage.

Age requirements from the date of first registration;

- Motor Cars: Between 18 months and 4 years.
- Dual purpose vehicles: Between 18 months and 3 years.
- Goods vehicles: Not more than 6 years.
- Vans: Not more than 4 years.
- Motor buses: Not more than 3 years.

(Kindly refer to the relevant Mauritius regulations for used vehicle imports)

All used vehicles must meet the requirements of this mandated pre-export inspection to enable issue of a certificate of conformity.

Application and inspection procedure

- (1) Please email/fax our Admin team after completing the EAA Booking form for Mauritius. Kindly append the copy of **Export Certificate and Auction Sheet** at time of application. Please note that the inspection cannot be conducted when there is no Export Certificate.
- (2) We will email/fax an inspection invoice by return.
- (3) We will confirm the inspection place, the vehicle details, and the booked date of inspection, etc. by email/phone or fax, after payment is confirmed.
- (4) After the inspection has been successfully completed, our Admin team will send your inspection certificates to you.
